## SUMMARY OF BYLAW AMENDMENTS

A motion will be made at the Annual General Meeting to repeal the existing TIAA bylaws and replace them with the attached revised bylaws. The following changes have been made to these bylaws:

- Removal of objects these are no longer permitted to be embedded in the bylaws, Corporate Registries now requires that
  these are kept separate from the bylaws
- Change fiscal year from November 1 October 31 to January 1 December 31. This will facilitate accounting and will coincide with the membership year
- Clauses 3.1.1 and 3.2.1: membership dues are not a true receivable so this clause has been reworded
- Clause 3.1.2 Membership Sections: this clause has been removed since it was unnecessary
- Clause 3.4.1: this clause has been removed and replaced with a policy
- Clause 3.7: no current code of ethics exists, so this clause has been amended accordingly, and references to fines have been removed
- Clause 5.1: Change AGM to be held within six months of the fiscal year end rather than four months, so that it can be held in May
- Clause 6.2 Membership Dues: this clause has been removed since the annual membership dues would be included in the budget which is ratified by the membership at the Annual General Meeting
- Clause 7.3: Update clause re borrowing of funds to align with Societies Act requirements
- Clause 8.8.4: Requirement that in order for any member to be eligible for nomination as President must have served on the board previously for at least one year
- Clause 8.8.4: The Past President to assume the role of Treasurer
- Clause 8.9: Allow for option for removal of a board member by majority vote at a board meeting if they miss more than two board meetings in a fiscal year
- Clause 8.10: term of office changed to a two year term from a one year term
- Clause 9.1: updated the standing committees
- Clause 11.1: Specify that the books and financial records must be audited once per year
- Clause 15.1: Members wishing to inspect the Association books can do so at the Association office rather than at the Annual General Meeting

#### TIAA Recap for 2008/2009:

TIAA has had a very successful and rewarding year. We have 25 Contractors, 23 Suppliers and Manufacturers, 1 Affiliate Member and 14 Honorary Members.

First off, I would like to thank the TIAA Board of Directors for 2008/2009: Murray Wedhorn, Dan Gagne, Ron Richards, Doug Warnick, Laurie Peloquin, Brent Plume, and Mark Trevors. As you may not realize, they all put in many hours for the Association. A special thanks to everyone on the TIAA Committees. Thank you to all of you who attended the TIAA meetings and social functions. Without any of this, there would be no TIAA. This keeps the industry alive and together as an Association.

#### **Firestopping:** TIAC First Vice President, Gerald Hodder

The Firestopping was an article I found in the New York Times. Commercial Construction is being driven by an agenda to get the work completed. As a result, a lot of the firestopping that is supposed to be behind the drywall is being omitted. Some of the contractors got caught and this got put into the media. This was an eye opener for the general public. People who are buying condominiums tend to look at the whole unit and don't realize they are buying into the greater building which includes the mechanical systems. TIAC is trying to educate the public so they understand this has to be done properly when you are buying real estate at the value in the \$300,000.00 to \$400,000.00 range. #### Western Canadian Mesothelioma Fund:

TIAA will be donating money to the Western Canadian Mesothelioma Fund. I have spoken to Andre Pachon, President of the B.C. Insulation Contractors Association. He has been unable to get in touch with Dr. Bedard to start setting up a screening facility in the Western Provinces but Andre is going to contact a Dr. Sat at the Health Science Centre Foundation in Winnipeg. If this doesn't work, there is talk of getting a Screening Bus with a CT Scan to go from Province to Province for the screening. The Balance in the Fund to date is \$30,251.69.

If they do not proceed with the above, the balance of the funds would be sent to the Princess Margaret Fund. This is the hub where the mesothelioma studies are currently being conducted at the Princess Margaret Hospital in Toronto. The money would be solely used for research in Mesothelioma. As we all know, screening is the only way to have a chance at surviving this disease with early detection.

#### TIAA Scholarship Applications:

I am very pleased with the increase in the TIAA Member Scholarships. For the year there has been:

- 2 First Year Insulators
- 4 Second Year Insulators
- 3 Third Year Insulators

Each applicant received a TIAA Member Scholarship for \$1200.00.

#### **Committee Reports**

#### Labour Report: Pat Pearson, Book Insulation

The upcoming 2010 year is looking more prosperous than what has been going on in the past year. There seems to be a lot of projects that were put on hold coming on line. On the commercial side it has been consistent. With all the shut downs and new construction there will be outside hiring. The demands will be unable to meet the work. The projection for the next few years is that the number of retirees is going to outweigh the new apprentices. We need to strive to get more apprentices into the trade.

There was a disagreement at Syncrude at the Surf Project. This was between the Teamsters and the Insulators in the hauling of materials. The umpire decided to give the hauling to the Teamsters. This has gone back to the Appeal Board

to get a legal ruling. Normally it is the Insulators work and we want to keep it this way in the future. I will update the TIAA members with the legal ruling.

#### **Apprenticeship Report:** Paul Blinzer (See attached to minutes.)

The reason why NAIT only has seven 3rd year apprentices is that in the last 3 months some of them have been unemployed and they did not have enough money to attend classes. The Union and the Apprenticeship Board have gotten involved and have sent threatening letters. If the apprentices don't return to complete their classes, they may suspend their apprenticeship. Hopefully in 2010 they will be able to afford to return with an improvement in the economy. If any TIAA member companies have apprentices that need to attend classes, there are lots of spaces available.

Your Asbestos Removal and Abatement ticket is only good for 3 years. If you have a group that would like to attend the class for Asbestos Removal and Abatement, NAIT can cater to a large group. Please contact the Registrar's Office at 780-471-6248.

The Budget for Skills Alberta 2010 was presented to the TIAA Board of Directors today. As far as I know, it was approved and the event is being held May 12 & 13, 2010 at the Northlands Agricom.

### **OH&S Report:** Ron Richards, Fuller Austin Insulation (see attached to the minutes)

The Occupational Fatalities in Alberta are not going down and there are just too many deaths.

The number of deaths in 1998 was 105 and in 2007 the death rate was 154. This was an article insert taken out of a 32 page document. The highest Occupational Fatalities age group is 45 + and the Workplace Fatalities age group is 25 - 44. Safety training and equipment are available to the employees so they should take advantage of what is offered by a company. Safety is most important to everyone at work.

Between 2003 and 2007 – 50.2% of Occupational Disease Fatalities were due to asbestos. The numbers are alarming and protective equipment is there for a reason. We will be talking about the Mesothelioma Program under New Business.

The Ski Trip is put on hold for the time being and we may do something else or a Ski Trip later in the year.


