New Energy Efficiency Programs for Alberta

The past 12 months have been very significant for the AEEA in terms of progress on our top priority – the establishment of new energy efficiency programs for Alberta. Ongoing engagement with the provincial government and other stakeholders has led to the announcement of the creation of a new energy efficiency agency for Alberta as well as \$645 million of funding over the next five years. These announcements will take Alberta from last place among provincial funding for energy efficiency programs to middle of the pack in the next two to three years. These programs are expected to significantly increase the demand for energy efficiency for both households and small to medium sized businesses in Alberta.

These announcements are the culmination of years of research and advocacy undertaken by the AEEA. In the last 12 months in particular, the AEEA has met with government officials, been a prominent participant in the climate change panel process (including as the lead facilitator for two of the panel's technical engagement tables), engaged with a wide range of stakeholders, and actively engaged media and the public on the topic.

The AEEA plans to remain a leading stakeholder voice as the province's energy efficiency agency is established and the design of new programs is undertaken.

Organizational Management

The AEEA has also continued to build our organizational capacity and ability to influence over this time.

As part of these efforts, the AEEA hosted two events over the past 12 months. This included our largest-ever event on March 2, 2016 that included a keynote address from Alberta's Energy Minister.

Over the past 12 months, the AEEA has also grown in membership. This included increasing the number of member organizations from 15 in 2015 to 21 as of May 2016.

As always, the AEEA has had strong financial management and reporting (undertaken by Gail Foster), and spending has remained on budget.

ALBERTA TRADE CONTRACTORS COALITION

The Alberta Trade Contractors Coalition (ATCC) Directors met in January 2016 and agreed to continue to support the ATCC Memorandum of Agreement. The coalition now sits at 10 signatory members. The coalition is also seeing expressions of support coming from the major electrical and mechanical unions.

The coalition members agreed to proceed on the following fronts:

1. Prompt Payment: Noting that the Alberta Construction Association (ACA) has made Prompt Payment one of their lobby priorities, the ATCC Directors have chosen to continue to raise awareness among government representatives and bureaucrats of what trade contractors feel are the priority requirements of new industry payment terms. To accomplish this, the directors have developed a leave behind flat sheet and power point presentation for use by the members.

ATCC Chairman, Terry Milot has been active meeting with his local NDP MLA, Rod Loyola and with the leader of the opposition Wildrose MLA Brian Jean. Mr. Jean has requested another meeting to gain more clarity on issue and Milot and Evans will be meeting with him this month.

MLA Loyola has prepared a private members bill in support of prompt payment that he intends to introduce to the provincial legislature later this year. He has been in contact with ACA in regard to getting ACA input to the bill. Milot and Evans will also be meeting with MLA Loyola.

At the provincial level, ACA has had some success in getting Alberta Infrastructure (AI) to clean up their payment processes, introducing four significant changes to their contracts:

- 1. The contract specifies a maximum of 30 calendar days after the initial receipt of the application for payment, provided the contractor has properly completed their claim. Infrastructure will verify the invoice and adjust if necessary, advise the General Contractor within 14 days of the amount to be paid. Infrastructure has modified the Statutory Declaration so that the General Contractor must confirm that they paid their subcontractors within 10 days of receipt of payment from the Government.
- 2. Their contracts specify that amounts which are not in dispute will be paid. Disputed amounts will be resolved during the next invoice period
- 3. Alberta Infrastructure has committed to publicizing the date of payment so that subcontractors and suppliers will be aware of when the prime contractor was paid (see contact info below).
- 4. Upon appropriate application, holdback funds will be released once the portion of the work is complete. The contractor will submit their certificate of substantial performance for their portion of the work performed, and follow normal procedures of posting the certificate at the job site. Infrastructure will verify substantial performance. After the 45 day period, the contractor then applies for release as part of the next progress claim. Warranty will still be from the date of Interim Acceptance.

At the National level ATCC Vice-Chair, Tim Padfield joined the NTCCC for national meetings and a lobby day on the Hill. While Padfield was in Ottawa, Senator Don Plett introduced for second reading the Canadian Prompt Payment Act. - 2. Other ATCC Trade Issue: At the January meeting the ATCC Directors identified three additional contractor issue that they feel are a priority to address:
 - 1. To establish appropriate change order processes and overburden charge out rates for overhead and profit. It was determined that the ATCC needs to conduct an industry survey to help justify appropriate overburden charge out rates from the sub-trade perspective and use these to inform owners, GCs and the Trades regarding acceptable practices in regard to change order processes.
 - 2. To develop improved standard for architectural drawings and engineering specification to improve estimating and bid procedures to minimize issues, errors and change order requirements. As it turns out the Canadian Construction Association (CCA) has just released a document as a result of a series of cross Canada meetings held to determine cause and find solutions to poor quality architectural drawings. Padfield and Evans attended the Calgary meetings and industry is now being asked to respond to the CCA report that can be found here: http://albertaconstruction.net/wp-content/uploads/2016/03/Std-Doc-Quality-CommitteeReport.pdf
 - ATCC members are encouraged to review the document and provide comment directly to CCA.
 - 3. To update the Alberta Construction Lien Act to address the current operating realities of the Alberta construction industry. The ATCC Directors believe there is opportunity to review results of the Ontario Lien Act review that is currently underway and build a case that can be presented to government to open and update the Alberta Lien Act. ATCC will be reviewing the input provided by industry to the Ontario Construction Lien Act Review (CLAR). The CLAR website can be found here: http://www.constructionlienactreview.com/
 - 4. Other ATCC:

In terms of the other trade issues being addressed by ATCC, all members are encouraged to discuss these with your respective board members and determine if these or other issues are your priorities. If there are others please bring them to the ATCC table.

As always if anyone is interested in the Insulator apprenticeship or in a tour of the SAIT campus facilities please contact myself.





LABOUR

The Oilsands and Oil Industry in our province has been experiencing very challenging times over the past 12 months, mostly due to the declining oil prices as shown below. Although the rebound in Q1-2016 is encouraging, our membership must continue to be prepared for a slow recovery.




What's encouraging to our province is articles such as this from Bloomberg where OPEC & non-OPEC producers are collaborating to freeze or reduce oil production. "Saudi Arabia and Russia agreed to freeze oil output at near-record levels, the first coordinated move by the world's two largest producers to counter a slump that has pummeled economies, markets and companies. While the deal is preliminary and doesn't include Iran, it's the first significant cooperation between OPEC and non-OPEC producers in 15 years and Saudi Arabia said it's open to further action".



Considering all of the negative economic forecasting and speculation that we read, the general health of our TIAA membership appears to be respectable. In Alberta, between the three MEGA projects (Suncor FH's, NWR & CNRL), other CAPEX & OPEX Projects, the current Turnaround season and the normal Operations & Maintenance work needing to occur our Insulation tradespeople do not appear as significantly impacted compared to other industrial trades.

The construction industry in general will continue to be as volatile as history indicates with significantly lower peaks over the upcoming years. Below is a chart provided by COAA:

TIAC REPORT

I attended a board meeting in Saskatoon on May 13th on behalf of TIAA. Remember that my first priority is to TIAA and our members. If there are issues that you want to bring up to the TIAC board, I need them in writing so I can explain them correctly and bring them to the forefront.

To start off is to bring to everyone's attention in Alberta the changes for the new Alberta Infrastructure building code. TIAC, AEEA and Local 110 have been lobbying with the Alberta government to enforce the use of mechanical insulation within the building code. The first implementation was the ASHRAE 90.1 2010 standards for the piping and ductwork insulation thickness. The others all make reference to TIAC which shows that they have been working behind the seen to improve our industry. These are the implementation of the TIAC Best Practices Guide, workers properly certified in Alberta companies and are members of TIAC. Please find attached two sections of the specifications, "Piping and Equipment Insulation "and "Ductwork and Breeching Insulation "that makes references to the above statements.

For the 54th annual TIAC conference coming up in September, please go on the TIAC website and click on this item and review the video that this committee put together for this event. Their team has worked very hard to accommodate everyone's suggestions for a conference for both program events and spouse's events. This should be a very educational and fun conference to attend by both members and spouses.
